



Memorandum of Understanding

This Memorandum of Understanding (MoU) is executed at Pune on this 2 day of April 2025

Between

Leadership For Skilled Education Foundation, a Section-8 company registered under 2013 Companies Act, whose registered office is at Flat 2A/2B, Alankar Building, Narveer Tanaji Wadi, Shivaji Nagar, Pune - 411005, Maharashtra hereinafter referred to as "First Party" which expression shall unless repugnant to the subject or context or meaning thereof include its successors and assignees) represented by its duly authorized signatory Mr. Madhukar Reddy Banuri of the FIRST PARTY.





SNDT College of Education, Pune a conducted college of SNDT Women's University, Mumbai and having its college at Karve Road, Pune- 411038 (hereinafter referred to as the "**Second Party**" which expression shall unless it be repugnant to the context or meaning thereof be deemed to mean and include its successors and permitted assignees) represented by its duly authorized signatory Prof. Sangita Nandkumar Shirode of the **SECOND PARTY**.

Each Party collectively referred to as Parties and Both Parties as above have expressed a desire to enter into a MoU to meet their respective objectives, which are set out herein below.

IN CONSIDERATION OF MUTUAL PROMISES AND THE MUTUAL COVENANTS SET FORTH HEREIN WHICH ARE HEREBY ACKNOWLEDGED, THE PARTIES HERE TO COVENANT AND AGREE AS FOLLOWS:

1. The Parties are hereby entering into this MoU in good faith to enable paid internship opportunities to the students of the Second Party in the schools of Pune.
2. This arrangement shall be in effect from **01 April 2025 to 31 May 2027**. This MoU can be mutually extended upon expiry of the Term. Unless renewed by Parties, the present MoU shall stand terminated upon the expiry.
3. The First party will organise the orientation session for the students. Interested students from the final year batch of B.Ed./ITEP course can enroll to the PCET program run by First party for every academic year for the internship engagement for 20 weeks. But there shall be no compulsion to the students to take part in this program, they will have choice to take part in this internship program.
4. The First Party will arrange internship opportunities for the students of the Second Party, as per the college schedule.
5. The facilitator/s from LSEF and SNDT College of Education, Pune will visit the internship school to observe the classroom teaching of the students.
6. The first party will allow students to complete all activities mentioned in the SNDT Women's University's syllabus of B.Ed. program under EWF.
7. The first party will make available their partner schools to the students of the second party to practice their teaching internship within the Pune City area.
8. The First Party shall facilitate internship opportunities for all students in its partner schools. A selected number of these internees shall be merit-based and shall include a monthly stipend, the amount of which shall be determined in mutual agreement with the respective placement schools.
9. During the Internship period on every Saturday students of the Second Party will be sent to the college for their academic work.

10. If any student of the Second party needs support regarding a change of the internship offered by First party, the student will be supported by First party towards the same.

11. The First Party will support the students to secure full-time employment in partner schools, contingent upon the school requirement & selection process and successful completion of the internship.

12. Neither Party shall have any liability to the other for any loss profits or revenues or for any indirect, incidental, consequential, cover, special, exemplary or punitive damages, however, caused, whether in contract, tort or under any other theory of liability, and whether or not the Party has been advised of the possibility of such damages.

13. Either Party shall have the right to terminate this Agreement by giving one (1) month notice without assigning any reason.

14. Any notice or written communication provided for in this Agreement by any Party to the other shall be delivered in person or by email at the address set forth below. All notices and communications shall be sent to the address set forth below unless changed by a Party by prior notice to the other Party.




